## UNDERSTAND FREEDOMS AND LIBERTIES WE ENJOY IN AMERICA DO NOT LOSE OUR CONSTITUTION

- \* Mature men are allowed to marry prepubescent girls Qur'an (65:4)
- \* Husbands may beat their wives. Qur'an (4:34)
- \* Husbands may rid themselves of undesirable wives. Qur'an (4:129)
- \* A man may have up to four wives. Qur'an (4:3)
- \* Slave girls are the sexual property of their male masters. Qur'an (4:24-25)
- \* A woman's testimony is only equal to one half of a man's. Qur'an (2:282)
- \* Males receive twice the inheritance of females. Qur'an (4:11)
- \* Husbands are a degree above their wives. Qur'an (2:228)
- \* Women are the sexual property of their husbands. Qur'an (2:223)
- \* Women found guilty of lewdness, with the testimony of four witnesses, may be sentenced to confinement until death. Qur'an (4:15)
- \* Men found guilty of lewdness are to be punished, then if they repent, are forgiven and are to be left alone. Qur'an (4:16)

## SHARI'AH LAWS/RESTRICTIONS ARE PER ISLAMIC RESEARCH FOUNDATION INTERNATIONAL, INC.

- \* A husband can instantaneously divorce his wife, or wives and then remarry again.
- \* A woman must pay money to her husband for a divorce.
- \* A woman's testimony is unacceptable in cases of adultery or capital offenses.
- \* Adoption is not allowed in Islam.
- \* Abortion is not allowed in Islam.
- \* Custody of children normally goes to the mothers until a boy reaches age 9 and a girl reaches age 7, then they go to the father. If the woman remarries or does not pray then the children immediately go to the father.
- \* Apostates automatically receive a death penalty. If they are not apprehended, they are automatically divorced from their
- \* husbands and are not able to receive an Inheritance from their parents.
- \* Muslim men can marry a non-Muslim, but women cannot.
- \* Muslim virgins are not allowed to marry without consent from their male guardians.
- \* A Muslim man may marry a woman for a fixed amount of time, a few days to several years, for his convenience. This is called (Marriage of pleasure).
- \* Islam encourages husbands to "discipline" their wives if they refuse to sleep with them; however, they are not to break any bones, teeth, leave marks, or do anything that makes them "ugly". The husband may beat them up to ten times with a small rod. This is to honor them.



### Husbands may rid themselves of undesirable wives:

In the book "Princess," in March 1, 2001 biographer Jean Sasson writes about a Saudi royal princess, Sultana, who was given to another member of the royal family without her approval. Sultana's older sister had already been given in marriage at age sixteen to a sixty two year old man that beat and sexually abused her. Sultana was much more fortunate as she had fallen in love with the prince she had been given to. They had a very good marriage by their standards, lived in extreme luxury, until he informed her that he was going to take an additional wife to give him children.

She also writes about another princess that met an American student and ended up running away with him to the United States. Eventually he grew tired of her and moved on.

She had no means of caring for herself so she felt she had to return home. In the meantime, her parents had been killed in an accident. So her uncle became head of the household. He forced her to marry a man in his fifties. She rebelled and ridiculed the man so he divorced her and dumped her at the uncle's house. He then sentenced her to "the women's room."

The women's room was a specially built room with soundproof walls, no window, a hole in the floor

for relieving herself, and a slit in the bottom of the door to receive food. She was to stay there until she died, no matter how long it took, or until her uncle died, and maybe other relatives would free her. This book is filled with incidents of unimaginable, barbaric treatments of women from cover to cover.

We frequently read about or see on the news stories of Muslim women being mistreated, women stoned to death in Somalia, Iran, Bangladesh, and Pakistan.

The Muslim population in the U.S. is growing rapidly, they are coming from those nations bringing their customs and laws with them.
